

**ANDREWS TOWN COUNCIL MINUTES  
OF PUBLIC MEETING HELD JUNE 11, 2018**

A public meeting of the Town Council of the Town of Andrews, Indiana convened on June 11, 2018 at 6:00 p.m. in the Andrews Municipal Building in accordance with applicable law and pursuant to appropriate notice.

**ROLL CALL:**

Council Members William Johnson, John Harshbarger and Bonnie Walker were present. Clerk-Treasurer Laura Dillon declared a quorum was present and the meeting would continue.

**APPROVAL OF COUNCIL MINUTES**

Bonnie Walker made a motion to approve the council minutes for the meeting of May 29, 2018, seconded by William Johnson. Motion passed unanimously.

**OLD BUSINESS**

There was no old business to report.

**NEW BUSINESS**

Dillon has completed a State Revolving Loan Request #26 for State Revolving Loan Funds of payment to Thieneman for \$296,668 and OCRA funds of \$37,312.27 for the new wastewater treatment plant. John Harshbarger made a motion to approve the payment of \$296,668 for SRF and \$37,312.27 for OCRA, seconded by Bonnie Walker. Motion passed unanimously.

The town received correspondences from Stantec on June 7, 2018 regarding groundwater monitoring wells and inspecting lines with a camera in advance of installing a cured-in-place liner. Scantek also indicated they were removing soil east of the intersection of California Street and Colorado Street beneath California Street. John Harshbarger will get in contact with Stantec to clarify exactly what is being done.

President Johnson reported he will contact Metro Net to correct problems on McKeever Street with the borings they did in the fall of 2017. Yards and sidewalk concrete are eroding and need repaired.

**DEPARTMENT REPORTS**

No police department report.

No fire department to report.

Colin Bullock, utility superintendent informed council of the new sidewalks and mulch at the park. The lift truck is currently being serviced. Everything is out of the vacant community building and will be demolished soon. An INDOT representative came through town because of complaints of overgrown trees on SR 105 (Main Street) from California Street to the railroad tracks. Town staffers will trim the trees.


Clerk-Treasurer Dillon reported the gasoline monitoring systems needs repair. The town has received a letter from Thieneman regarding the E-verify violation.
